

## CONTRA COSTA COUNTY PUBLIC WORKS DEPARTMENT

### ROUTES AUTHORIZED FOR ANNUAL TRANSPORTATION PERMITS

Those County of Contra Costa maintained public roads listed in Column 1 of the following table are authorized for movement under the terms and conditions of a County Annual Transportation Permit, but only to the extent described in Column 2 and only in accordance with the limitations shown in Column 3, 4, and 5. **Movements on County roads not listed in this table, or on segments of the listed road beyond those described in Column 2, are not authorized unless specifically written into the face of this permit.**

Notes:

1. Unless otherwise specified in this column and/or on the face of this Permit, movements shall be limited to travel in either direction through those roadway segments described in this column. Movements through any under or over crossing of State Routes in this roadway segment require State permits, movements through contiguous City roadways require City permits, and movements onto contiguous roadways maintained by any of the adjacent counties (Alameda, or San Joaquin) require permits from the affected County; the restrictions and limitations imposed by these other agencies may or may not be the same as those described in columns 3, 4, and 5.
2. Weekend movements on any of the listed road segments are only authorized if so indicated on the face of the permit; such an authorization on any segment indicated as "No" in this column will only be granted in extraordinary circumstances.
3. After-dark movements on any of the listed road segments are only authorized if so indicated on the face of the permit; such an authorization on any segment indicated as "No" in this column will only be granted in extraordinary circumstances.
4. **Movements requiring a pilot car escort are not authorized for either weekend or after-dark travel.**
5. **Movements requiring escorts by multiple pilot cars and/or by the California Highway Patrol or other uniformed police officer are not authorized for travel under this permit.**
6. Route Classification is based upon Caltrans "Route Color Classification Guide".
