Home Equity Preservation Alliance (HEPA) – Richmond City Administration http://www.ci.richmond.ca.us/index.aspx?NID=1377

The website, hosted by the City of Richmond, is an effort to provide a single point of reference and up-to-date information for residents throughout Contra Costa County. HEPA is a collaboration of Community Housing Development Corp. of North Richmond, Housing Rights, Inc., Pacific Community Services, Inc., Bay Area Legal Aid, and Housing & Economic Rights Advocates. It gives information on what to do when you have trouble making mortgage payments; free foreclosure seminars and workshops; what happens when a mortgage payment is late; provides a brief explanation of how lenders react to late payments; and list of definitions of words you may hear as you address your mortgage payment challenges. In addition, there are links to other non-profit organizations that may provide assistance.

It provides homeowners with loans owned or guaranteed by Fannie Mae or Freddie Mac information about refinancing into more affordable monthly payments. The Home Affordable Modification Program helps homeowners stay in their homes by preventing avoidable foreclosures. Website provides tools for eligibility for refinancing and home modification, helps locate a HUD approved housing counselor, and related tools.

They provide a wide range of services including counseling, legal immigration assistance, counseling for homeowners facing foreclosure, emergency rental assistance, case management for residents of the Monument Corridor, housing advocacy for people with HIV/AIDS, and services for children who are at risk of entering foster care.

Community Housing Development Corporation (CHDC) – Post-Purchased Homeownership Program

CHDC works in partnership with several agencies helping homeowners who may have fallen victim to predatory lending or who entered the market with a teaser adjustable interest rate that has become unaffordable. Program covers delinquency and foreclosure counseling, refinance counseling, deed restriction counseling, home maintenance workshops, home maintenance referrals, emergency preparedness workshops, anti-predatory lending workshops, reversed mortgage counseling referrals, loan document review tax and insurance counseling and referral. They provide a variety of services including: job readiness and training, CalWORKs Work Experience, home ownership and foreclosure workshops and counseling, offers lead education, operates Hand to Hand Collaborative which provides home visits and case management for Asian and African American females that are pregnant and/or have a child under the age of 4 months, provides crime victim assistance to Asian-Americans with limited English, provides refugee resettlement services and during tax season operates a EITC Center. Lao Family Community Development is an affiliated One-Stop Career Center.

Provides comprehensive housing counseling for people in Contra Costa County and Alameda County seeking to purchase or avoid foreclosure. Offers workshops for first-time home buyers, foreclosure prevention, and other housing issues; workshops are listed on the website. The agency is a HUD certified counseling agency.

They provide housing counseling services, including confidential mortgage default and delinquency counseling to families who are in danger of losing their homes through foreclosure or eviction. Does not provide rental assistance but presents option on how to respond to eviction notice. Offers mediation of tenant/landlord disputes, assistance to tenant organizations, tenant/landlord rights, legal counseling referrals, pre-purchase / pre-rental counseling and home buyers training, referrals for social services, legal services, health problems, alcohol/drug abuse and social security benefits. Fair housing activities include documentation and verification of complaints and legislative training. They serve all Contra Costa cities except Concord.

## San Francisco Bay Area and Nationwide

They provide home ownership assistance by helping individuals refinance predatory loans leading to foreclosure. Refinance eligibility is listed on website or can be obtained by phone. If eligible, individual must attend workshop as the first step in gaining assistance; the workshops usually take place on a Saturday for four hours. They provide detailed information for a participant to become NACA Qualified or mortgage-ready. In addition to the workshop, a Mortgage Submission form must be completed either online or at the office. NACA is a membership program, costing \$20 for membership with all services free to members.

Provides legal advice to low and moderate income residents regarding foreclosure and predatory mortgage lending, advises tenants in foreclosed on properties of their legal rights but does not represent tenants; advises on other related matters. Free loan modification advice and assistance for individuals for their primary residence. They provide litigation in some cases. Intake is Monday to Thursday, the first 3 weeks of the month.
