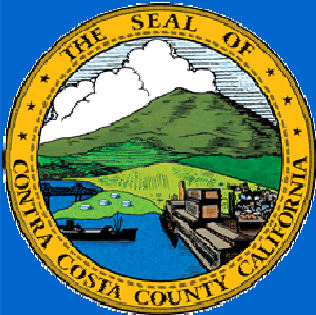

MANAGEMENT DISTRICT GRANT
FUNDING**

The Bay Area Air Quality Management District is accepting applications for their Bicycle Rack Voucher Project until January 31, 2014, or until funds are exhausted. Some brief information is available below. [More information can be found online](#).

- Funds available to public agencies in the Air District's jurisdiction.
- Awards made in the form of Vouchers for up to \$60 per new bicycle parking spot created, limited to a maximum of \$12,000 in total Voucher awards per applicant.
- Vouchers may be redeemed for qualified equipment with Vendors on contract with the Air District.
- An application workshop is being planned for late October and will be held at the BAAQMD and online via webinar.
