PRESENTATION OF COLORS: Vice Chair Allen led the Pledge of Allegiance.

<u>APPROVAL OF AGENDA:</u> Motion made by Councilmember Bittner to approve the agenda as prepared. Second made by Councilmember Montgomery. Motion Carried 5-0. AYES: Allen, Bittner, Cameron, Montgomery, Quick.

PUBLIC COMMENTS: None Received.

REPORTS:

- a. Office of the Sheriff: Lt. Beltran provided an update regarding an overview of incidents for February 2014, which included, DUIs, Drunk in Public, Assaults and several warrant arrests. Sergeant Gary Madison introduced himself and provided the group an overview of the Sheriff's Marine Patrol Division including the vessel abatement program. Sergeant Madison then discussed several specific vessels of concern with the community.
- b. California Highway Patrol: No representative present.
- c. Fire/Public Safety: Chief Henderson distributed the overview of the district's statistics for the month of February 2014 with total 496 calls for the entire district. Chief Henderson provided an update regarding the Fire Boards decision not to move forward with a parcel tax in June. The next East Contra Costa Fire Protection District meeting is scheduled for April 7th.
- d. Citizens' Fire Committee: Mark Whitlock discussed his concern with response time if additional revenue is not received by the Fire District. Mark stated that he is continuing to work on the dry hydrants. Provided an update that BIMID is working on abatement of trees and bushes on the levees and is sending letters to property owners.
- e. District III Supervisor's Office: Field Representative Cornell provided an update on the following items: Comment period for the Bay Delta Conservation Plan EIS/EIR is open until April 14, 2014; Caltrans will be performing work on Highway 160 with overnight closures; the Contra Costa Superior Court is accepting applications for the 2014-2015 Civil Grand Jury; discussed a memo regarding changes to the Brown Act requiring listing of members votes on action items; provided an update the Code Enforcement staff have moved forward with Recording a Notice of Pending Abatement on the Styrofoam docks located just over the bridge; provided copies of the Counties Vessel Sanitation and Mooring Ordinance; lastly distributed copies of March 17 Zoning Administrator meeting agenda.
- f. Heart Safety: Councilmember Montgomery provided an update on the status of the Heart safe communities program and the need for a Doctor's signature for placement of additional units. Discussion as to how to get the unit that is currently located at Caliente Harbor located in another area of the island.
